- WHEREAS, the Department of Labor and Employment - Regional Office III intends to purchase 5,173 pieces of TUPAD Longsleeve T-shirt and Cap with an approved Purchase Request No. 116-21 with an Approved Budget for the Contract (ABC) of One Million Eight Hundred Ten Thousand Five Hundred Fifty Pesos (Php 1,810,550.00) as contained in the Annual Procurement Plan CY 2021;
- WHEREAS, that Negotiated Procurement under Emergency cases where immediate action is necessary to provide community-based package of assistance through emergency employment for disadvantaged/displaced workers for a minimum period of ten (10) days to do community clean-up, declogging of canals (roads, markets and other public places) and other minor community works for the province of Tarlac (District I and II).
